# **DECLARATION OF L. GARY DAVIS**

- I, L. Gary Davis, being duly sworn according to law, hereby declare and state as follows:
- 1. I am the Chief Financial Officer and Vice President for Bodybuilding.com, LLC.
- Bodybuilding.com, LLC ("Bodybuilding.com") is an Idaho company 2. operating the website www.bodybuilding.com, and featuring an online forum (the "Forum") open to the public, where members and those with shared and similar interests can exchange thoughts, ideas, comments, recommendations, advice, etc., on issues affecting the bodybuilding community.
- 3. On July 23, 2007 my company received a letter from Charles Lee Mudd, Esquire of the Mudd Law Firm, requesting that Bodybuilding.com ensure that it preserves all information relating to a total of 265 pseudonymous speakers appearing on the bodybuilding.com forum. All information has been preserved pending the outcome of this litigation. A true and correct copy of the July 23, 2007 letter is attached hereto as Bodybuilding.com Ex "A-1."

- 4. The registration process on the <u>www.bodybuilding.com</u> user's Forum does not require the user to supply their name or any identification information. Any contact information provided to Bodybuilding.com is provided strictly on a voluntary basis.
- 5. Under my direction, employees of Bodybuilding.com searched the registration records of all members of the bodybuilding.com Forum site. I instructed that the identity and contact information for all 22 pseudonyms listed in Plaintiff's Motion to Compel be located. This search returned nine (9) of the twenty-two (22) pseudonyms without any identification or contact information in our records. Specifically, no information exists for pseudonyms "Androgenic," "BuckeyeMuscle," "canadaBBOY," "ditto," "Ephedra," "Indenium," "jkeithc82," "RobW," and "uhockey."
- 6. The document attached hereto as Bodybuilding.com Exhibit "A-2" is a true and correct posting made on bodybuilding.com Forum message board on July 9, 2007 by pseudonym "SI03 Board Rep."
- 7. The document attached hereto as Bodybuilding Ex "A-3" is the Terms and Services appearing on the <a href="www.bodybuilding.com">www.bodybuilding.com</a> website which govern use of the bodybuilding.com users Forum.
- 8. If forced to disclose the identities of any of the pseudonymous speakers from the bodybuilding.com Forum, the result will be catastrophic to the Forum and to our business, as other members will become fearful of posting any negative comment about any supplement company or its products, on account of a fear of litigation. I believe Forum members will ultimately abandon the site, thereafter seeking out a location where they can exchange in open and honest non-biased discussions about issues affecting the bodybuilding community.
- 9. As a company, Bodybuilding.com, LLC has an obligation to the Forum members to protect their anonymity from unauthorized disclosure. Our company's reputation

and business relies on the ability of visitors to speak openly and honestly, and anonymously about issues affecting the bodybuilding community.

- 10. Bodybuilding.com, LLC as a business relies heavily on the internet traffic which enters and posts messages on the Forum site. Any loss of traffic to the Forum will ultimately result in fewer visitors to the business site and thus the existence of our company as a whole may be severely prejudiced by being forced to disclose the identities of anonymous speakers.
- 11. I understand that on page 10, footnote 2 of Plaintiff's Memorandum in Support of Motion to Compel, SI03, Inc. claims that "Bodybuilding.com took it upon itself to inform its forum members of SI03, Inc.'s Complaint and the subpoernas issued upon Bodybuilding.com." This statement is false, as neither notice of the Complaint nor the Subpoenas was made by Bodybuilding.com to its Forum members.

I declare that all facts and allegations contained in this Declaration are true to the best of my own knowledge; that all statements made herein of my own knowledge are true and that all statements made on information and belief are believed to be true; and further that these statements were made with the knowledge that willful false statements and the like, so made, are punishable by fine or imprisonment, or both, under Section 1001 of Title 18 of the United States Code and that such willful false statements may jeopardize the validity of this Declaration.




